

In 2009, EFFA asked its member associations a range of questions about farriery training, regulation and the numbers of horses and farriers. EFFA plans to put the results on its website, but in the meantime the following summary makes interesting reading, and will be especially useful to any farrier thinking of working abroad. There is information from Austria, Czech Republic, Denmark, Finland, France, Germany, Great Britain, Holland, Hungary, Sweden and Switzerland.

## What is the youngest age at which you can start to train as a farrier?

Age 15: Czech Republic, Denmark, Germany

Sweden: 1 or 2 years depending on college

Switzerland: 4 years
